_____ **Payment Option 1:** Purchase price of \$2750.00 + 7% Ohio tax with a 24 month hip guarantee and limited AKC papers (puppy must be spayed or neutered)

_____ **Payment Option 2:** Purchase price of \$3250.00 + 7% Ohio tax with a 24 month hip guarantee and unlimited AKC papers

Guarantee

The seller warrants that the puppy is in good health at the time of purchase. The buyer agrees to have their puppy be examined by a licensed veterinarian within 2 days (not including weekend or holidays) of receipt of the puppy. If results of the examination show that the puppy has a life-threatening illness then the buyer shall elect to keep the puppy or return to seller for a refund. If the buyer elects to return the puppy, the buyer shall, within 10 days after signing this contract, send to the seller a certified receipt from the veterinarian. If the buyer elects to return the puppy, they are obligated to return the puppy to the seller at the buyer's expense. Upon receipt of the puppy, the seller shall be obligated to refund all monies received from the buyer towards the purchase of the puppy and further performance under this contract shall be null and void. All action to return the puppy will be done in the best interest of the puppy.

The seller is not responsible for any vet bills or medication after the sale of the puppy. This includes any illness from Coccidiosis, parasites, viral or bacterial infections, bloat or parvovirus. These conditions are outside of the seller's control. Also note that being over weight as well as running and jumping up and down stairs causes injury to a dog's shoulders and hip joints and will void the 24 month hip guarantee. The guarantee does not cover for accidents, injury, neglect or abuse contributing to hip disease.

If your puppy develops debilitating hip dysplasia within 24 months from their date of birth due to genetics, the buyer may return the puppy to the seller and will receive a replacement puppy of like quality of next available litter or may choose to keep the dog and the seller will refund \$500. The buyer will need to send the seller a certified receipt/documentation of genetic fault from a certified veterinarian and a copy of the x-rays. All vet costs and related expenses of returning the dog to the seller shall be in the obligation of the buyer. Contract is VOID if the dog is overweight.

The buyer agrees that they are not acting as an agent in the purchase of this puppy and that the buyer will not sell this puppy to an agent, pet store, or guard dog business. The buyer agrees that the puppy will reside at the home of the buyer and will be provided with proper food, housing, vaccinations, and adequate exercise.
